

# NOTICE OF PUBLIC MEETING

### Purpose and Effect

The purpose and effect of the application for consent is to sever a parcel of land to facilitate the disposal of a surplus farm dwelling as a result of a pending farm consolidation having a frontage of approximately 57.73 m (189.4 ft) along Concession Drive (County Road 14) and an area of approximately 0.27 ha (0.67 ac) from an agricultural parcel of land with an area of approximately 18.34 ha (45.32 ac). The severed lands would contain a single detached dwelling, and a detached garage. The lands are serviced by a privately owned well and septic system and have an existing access from Concession Drive (County Road 14).

The lands proposed to be retained would have a broken frontage of appoximately 1162 m (3812.33 ft) along Concession Drive and an area of 18.07 ha (44.65 ac). The retained lands are used for agricultural purposes in the form of field crop cultivation and contain a barn, silo and farm buildings to be removed. Access to the agricultural lands will need to be verified or a new access established as a result of the severance application.

The subject lands are designated 'Agricultural' within the Southwest Middlesex Official Plan and are zoned 'General Agricultural (A1)' within the Southwest Middlesex Zoning By-law. Portions of the retained lands are regulated by the Lower Thames Valley Conservation Authority.

A location map is attached for reference.

### Description and Location of Subject Lands

The subject lands are located at the northeast corner of Concession Drive (County Road 14) and Old Airport Road, abutting the CN Railway. The lands are legally described as South Part of Lot 3, South Part of Lot 4, Concession 2, South Side of the CN Railway, Municipality of Southwest Middlesex (Mosa).
