#### Purpose and Effect

The purpose and effect of the Temporary Use Zoning By-law Amendment application is to permit two single-detached dwellings on the subject land for a temporary period not to exceed two (2) years while a new dwelling is being constructed on the property. The existing dwelling would be removed from the property upon the expiration of the two-year period or the occupancy of the new dwelling; whichever occurs first.

The subject lands are approximately 39.45 ha (97.5 ac) in size and contain a single detached dwelling, a tool shed, a storage shed, and a barn. The lands are serviced by a privately owned well and septic system and have an existing access from Shields Siding Road.

The subject lands are designated 'Agricultural' within the Southwest Middlesex Official Plan and are zoned 'General Agricultural (A1) Zone' within the Southwest Middlesex Zoning By-law. The lands contain natural heritage features including significant woodlands. Portions of the lands are regulated by the St. Clair Region Conservation Authority.

A location map is attached for reference.

In accordance with Section 34(10.4) of the <u>Planning Act</u>, R.S.O. 1990, c. P.13, as amended, the Municipality of Southwest Middlesex has deemed the rezoning application to be complete for the purposes of Section 34(10.1) and (10.2) of the <u>Planning Act</u>.

#### **Description and Location of Subject Lands**

The subject lands are located at the southwest corner of Shields Siding Drive and Pratts Siding Road. The lands are legally described as North Part of Lot 9, Concession 7, Municipality of Southwest Middlesex (Mosa).

The Clerk will contact all persons who indicate in their written submissions that they intend make oral submissions at the meeting to provide electronic access instructions.

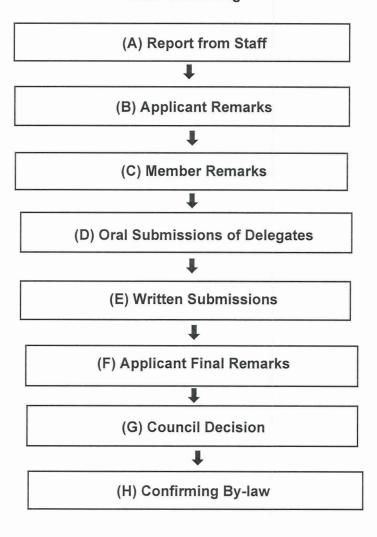
Submissions during the Oral Submissions of Delegates (Part D) part of the meeting are encouraged whenever possible.

#### **Order of Meeting**



If a person or public body would otherwise have an ability to appeal the decision of the Council of the Municipality of Southwest Middlesex to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Southwest Middlesex before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Municipality of Southwest Middlesex before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
