#### Purpose and Effect

The purpose and effect of this Application for Temporary Use is to permit a travel trailer on the subject land for a temporary period not to exceed November 15, 2024, while a dwelling is being constructed on the property. The travel trailer would be removed from the property upon the expiration period or the occupancy of the new dwelling; whichever occurs first. The applicants have also requested to allow the travel trailer to have a reduced rear yard depth of 6.09 metres (19.98 ft) whereas the Rural Residential (RR) zone requires a rear yard depth of 10 metres (32.80 ft).

The subject lands are approximately 1335.46 square metres (0.33 ac) in size and are vacant. The lands are to be serviced by municipal piped water and a privately septic system and would require access from Longwoods Road (County Road 2).

The subject lands are designated 'Agricultural' within the Southwest Middlesex Official Plan and are zoned 'Rural Residential (RR) Zone' within the Southwest Middlesex Zoning By-law.

A location map is attached for reference.

In accordance with Section 34(10.4) of the <u>Planning Act</u>, R.S.O. 1990, c. P.13, as amended, the Municipality of Southwest Middlesex has deemed the rezoning application to be complete for the purposes of Section 34(10.1) and (10.2) of the <u>Planning Act</u>.

### **Description and Location of Subject Lands**

The subject lands are located at the northwest side of Longwoods Road (County Road 2), between Big Bend Road and Pratt Siding Road. The lands are legally described as North Part of Lot 10, Range 1 North and designated Part 1 on Reference Plan 33R-12559, Municipality of Southwest Middlesex (Mosa).

### **Hybrid Planning Act Public Meeting**

The Clerk will contact all persons who indicate in their written submissions that they intend make oral submissions at the meeting to provide electronic access instructions.


Submissions during the Oral Submissions of Delegates (Part D) part of the meeting are encouraged whenever possible.

#### **Order of Meeting**



If a person or public body would otherwise have an ability to appeal the decision of the Council of the Municipality of Southwest Middlesex to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Southwest Middlesex before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Municipality of Southwest Middlesex before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
