

# NOTICE OF PUBLIC MEETING

### **APPLICATION FOR CONSENT (B21-2024)**

#### **Purpose and Effect**

The purpose and effect of Application for Consent B21-2024 is to sever a parcel of land to facilitate the disposal of a surplus farm dwelling as a result of farm consolitation. The lands as a whole have an area of approximately 40.5 ha (100 ac) and a frontage of approximately 604 m (1,981.63 ft). The lands proposed to be severed would have a frontage of approximately 63 m (206.7 ft) along Falconbridge Drive and an area of approximately 0.23 ha (0.58 ac). The lands proposed to be severed contains a single detached dwelling and are serviced by a private well and private septic system. These lands have an existing access from Falconbridge Drive. The lands proposed to be retained would have a frontage of approximately 541 m (1,774.93 ft) along Falconbridge Drive and an area of 40.23 ha (99.42 ac). The retained lands contain agricultural land in crop production. Confirmation of an existing access off of Falconbridge Drive, or the establishment of a new access off Falconbridge Drive will be required as a result of the severance.

#### **Description and Location of Subject Lands**

The subject lands are located on the southeast side Falconbridge Drive and between Tait's Road and McArthur Road. The lands are legally described as CON 2 N PT LOT 19, Municipality of Southwest Middlesex (Ekfrid).


Submissions during the Oral Submissions of Delegates (Part D) part of the meeting are encouraged whenever possible.

#### **Order of Meeting**



If a person or public body has the ability to appeal the decision of the Municipality of Southwest Middlesex in respect of the proposed consent to the Ontario Land Tribunal but does not make written submissions to the Municipality of Southwest Middlesex before it gives or refuses to give a provisional consent, the Tribunal may dismiss the appeal.

Notwithstanding the above, subsection 53(19) of the Planning Act defines the parties that are eligible to appeal the decision to the Ontario Land Tribunal.
