



# April 8, 2026 Council Meeting Highlights

Mark Brown, Woodland Conservation Officer & Durk Vanderwerff, Director of Planning and Development for the County of Middlesex presented the Middlesex County Woodlands Management Plan Update.

## At this meeting, Council:

- Received the Q1 2026 CAO quarterly update.
- Approved a policy restructuring report to adopt stand-alone by-laws for a number of policies previously approved under one by-law.
- Approved the renewal of the Animal Control Services Agreement with Southwest Middlesex Animal Shelter for a three-year term.
- In preparation for the 2026 municipal election, received a report on the Southwest Middlesex Delegation of Powers and Duties policy outlining authority delegated to the CAO if council faces restricted acts after nomination day and following election day.

## Tenders Awarded:

- BKT Excavating Ltd was awarded the Glencoe Business and Industrial Park Servicing project in the amount of \$2,411,260.60 (excluding HST).
- Miller Paving Limited was awarded the Surface Treatment tender in the amount of \$82,168.48 (excluding HST).
- Team Truck Centres (London) was awarded the Single Axle Truck Purchase equipped with snow and ice removal equipment in the amount of \$433,775.00 (excluding HST).
- McDonnell Motors Limited was awarded the purchase, supply and delivery of one 2026 Ford F-250 4x4 single cab and one 2026 F-250 double cab in the amount of \$143,228.50 (excluding HST).
- Birnam Excavating Ltd. was awarded the Industrial Road Sewage Pump Station Upgrades in the amount of \$1,369,503.43 (excluding HST).
