Verbal Update from Steve MacDonald, Facilities and Recreation Manager, RE Boiler Replacement at Glencoe Arena

Mr. MacDonald noted that a 42 year old boiler unit had a major leak which was discovered by staff over the Christmas Holidays during their regular checks. Staff undertook to have repairs completed and worked with Gerber Electric for a new system. The procurement policy allows for emergency sole sourcing. The final work was completed January 9, 2018. The estimate is approximately \$17000 with potential rebate of \$2000. There is an expectation for improved efficiency for the new system.
