- 1) 2018 Aquatic Staffing to consist of seven full time instructors/guards (including one supervisor and two assistant supervisors) and two-part time instructors/guards.
- Applicants with three or more successive years of experience at our pool will not require an interview unless they are applying for a promotion.
- 3) Early registration to be held on a weeknight in early June with 10% savings offered at this event.
- 4) Opening the pool on Tuesday June 19th.
- 5) Continuing to offer the Swim to Survive program, starting on June 19<sup>th</sup>.
- 6) Free public swims on the evening of opening day, the afternoon of Canada Day, and the afternoon on the Sunday of Tartan Days.
- 7) The pool will remain open until Friday August 31st, with the final week's schedule for Monday to Friday being shortened to 12:30 to 4:30pm.
- 8) Special needs one-on-one 8-week lessons continuing to be offered.
- 9) The splash pad to remain open until end of day Monday September 3<sup>rd</sup>.

The Deputy Mayor, chair for the committee of the whole reported that the meeting was held for the purpose of discussing the landfills and to receive legal advice and personal information about an identifiable individual. Coming out of closed, council passed the following resolution in open session:

THAT staff be directed to close the Limerick Landfill immediately, and temporarily close the Trillium Landfill immediately; and

THAT staff be directed to engage a qualified engineering firm to undertake a cost analysis to perform remedial action to re-open the Trillium Landfill site; and further

THAT staff direct said firm to develop an RFP document to develop the operational plan for Trillium Landfill and closure plans for Limerick and Trillium Landfills, as per the ECAs; and further

THAT staff be directed to notify Sholdice Excavating of the termination of the contracts for Limerick and Trillium Landfills with payment of one month's fees, as per the contracts; and further

THAT staff be directed to sign agreements with Emterra and Waste Management to handle and dispose of domestic household waste; and further

THAT staff be directed to work with the Ministry of the Environment and Climate Change to implement a transfer site at Trillium Landfill for residential waste other than household pick-up; and further

THAT staff be directed to contact all outside municipal and private stakeholders at the landfills to inform them of the changes being made.
