- Southwest Middlesex approaches Strathroy-Caradoc to partner with us for five brackets to hang on Longwoods Road on the Southwest Middlesex side of Melbourne and the other five on the Strathroy-Caradoc side of Melbourne with Strathroy-Caradoc agreeing to reimburse Southwest Middlesex for five of the brackets and leaving all other aspects of the brackets and the banner programs to Southwest Middlesex and the Glencoe Legion.
- Southwest Middlesex to finalize the location for each bracket/banner with input from Strathroy/Caradoc and the Glencoe Legion.
