The purpose of the meeting is to consider the Engineer's Report on the reconstruction of the Miller Municipal Drain serving parts of Lots 9 to 11, Concessions Range 1 North and Range 1 South (geographic Ekfrid) in the Municipality of Southwest Middlesex. The total watershed area contains approximately 92.5 hectares.

The Mayor asked if there were any questions from Council. Questions were asked about: the process for notifying and discussing the project with affected landowners; projects associated with other portions of the Miller Drain and costs associated with the clean-out when there had been maintenance work.
