Announcement of Chair:

The purpose of this meeting is to give the public an opportunity to hear all interested persons with respect to a **Zoning Amendment Application by John Mark and Cheryl Charlton** and for Southwest Middlesex council to consider the proposal.

The purpose and effect of this Zoning By-law Amendment is to is to re-zone a portion of the subject lands from the General Agricultural (A1) Zone to a Site Specific General Agricultural (A1-11) Zone to permit the following uses accessory to the existing farm: 5 fully-serviced nature lodges, 3 farm suites, and season group events. The owners are proposing to establish an Agri-tourism business as a secondary farm occupation on the subject lands.
