The Chair introduced the Planners in attendance for the meeting. The Planner provided the summary of the application requesting to sever and convey a wooded parcel from an agricultural property with the abutting parcel owned by the Thames Talbot Land Trust.

Notice of the application was circulated as required. The Conservation Authority was circulated and had no concerns with the application. Ms. Poirier indicated that no written comments were received either for or against the application.

Ms. Poirier identified the recommended conditions that be applied if the committee opts to support the application and noted that a minor variance will need to be approved for the retained agricultural lot, as it will not meet the agricultural requirements.

THAT Application for Consent B01-2018, submitted under Section 53 of the Planning Act, which proposes to sever and convey a 30.3 ha (75 ac) parcel of land from the property legally described as Range 1N, S, Part Lot 24 (geographic Township of Mosa), be **GRANTED** subject to the following conditions:

- 1. That the Certificate of Consent under Section 53(42) of the Planning Act shall be given within one year of the date of notice of the decision. The request for the Certificate of Consent shall be accompanied by a written submission that details how each of the conditions of consent has been fulfilled.
- 2. That the owners' Solicitor submits an undertaking in a form satisfactory to the Secretary-Treasurer of the Committee of Adjustment to register an electronic transfer of title exactly consistent with the Acknowledgement and Direction executed by the applicants and the decision of the Committee of Adjustment.
- 3. That the taxes on the subject property are paid in full.
- 4. That the severed lands be merged with the abutting property to the North.
- 5. That a preliminary survey showing the lands being severed, be submitted to the satisfaction of the Municipality prior to being deposited at the Land Registry Office.
- 6. That two copies of the reference plan are submitted to the satisfaction of the Municipality.

Reasons

Consistency with the Provincial Policy Statement would be maintained;

Conformity with the County of Middlesex Official Plan would be maintained;

Conformity with the Municipality of Southwest Middlesex Official Plan would be maintained;

The requirements of the Municipality of Southwest Middlesex Zoning By-law would be maintained.
