**7. VERBAL UPDATES**

a. Reopening Ontario: Stage Two of Economic Restart – pools and splash-pads. The committee was notified the Lifesaving Society of Canada has published a document regarding the safe reopening of pools and splash-pads. The Middlesex-London Health Unit stated they would not release a guideline – but would shadow and support the Lifesaving Society’s document.

SWM (Glencoe) Swimming Pool maximum bather load: 175  
Lifesaving Society suggests no more than 25% capacity.

b. The use of sports fields is allowed for personal use, at own risk. No sports leagues will be permitted. Social distancing must be followed.

**8. COMMENTS AND ENQUIRIES**

- Chairperson Cowell suggests publishing that the SWM (Glencoe) Pool is available only to SWM residents – but if someone from outside SWM attends, don’t turn them away.
- Mayor Mayhew feels the bather load of 40 people (at 25% of 175) is sufficient and mimics past attendance numbers.
- Chairperson Cowell stated the pool on a day/night where public swimming is free due to sponsorship – the pool is known to have been at full capacity.
