a. Chairperson Cowell requested the meeting to provide updates to the Recreation Committee with the effects of COVID-19.

- Reopening of Glencoe Arena (September 23<sup>rd</sup>)
- Reopening of Ekfrid Community Centre (September 21<sup>st</sup>)
  - Requirements for both facilities include a "Return to Facility" form or "Return to Play (Ice)" form depending on which facility the renter is requesting.
  - SWM has allowed 4 spectators at the arena at a time, unlike surrounding municipalities, allowing 1
- The Southwest Middlesex RFP Recreation Master Plan is on the market
  - First Engage a Consultant to create the Recreation Master Plan
  - Second 6 months for successful consultant to work on creation of the Recreation Master Plan
  - Intended Outcome creates a long-term direction for Recreation in Southwest Middlesex

- Ideas presented for community initiative include ball hockey, volleyball, badminton, tennis – for Recreational Programming
- Results of the 2021 Budget Survey included requests to increase spending in recreation and recreation programming.
